

**THE STUDIO RULES & REGULATIONS  
AND  
CONTRACT**

TUITION FOR MY (DANCER'S CLASS(ES) IS DUE ON THE 5<sup>th</sup> OF EACH MONTH. I REALIZE THAT DURING THIS TIME, THE STUDIO WILL HOLD MY (DANCER'S) PLACE IN CLASS WHETHER OR NOT HE/SHE IS ABLE TO ATTEND CLASSES. A MONTH'S NOTICE IS REQUIRED IF HE/SHE IS NOT RETURNING TO CLASSES. ALL 12 MONTHS REQUIRE FULL TUITION PAYMENT (UNLESS NOTICED OTHERWISE) IN ORDER TO HOLD YOUR DANCER'S PLACE (EVEN IN THE SUMMER AND HOLIDAY MONTHS).

THE STUDIO HAS A NO REFUND POLICY. DANCERS MAY MAKE UP CLASSES BEFORE OR AFTER THE ABSENCES IN THE SAME LEVEL OR IN A LOWER LEVEL CLASS IN THE SAME MONTH OR AS SOON AS POSSIBLE.

THE STUDIO FOLLOWS THE AMADOR COUNTY UNIFIED SCHOOL DISTRICT CALENDAR FOR MOST SCHOOL DAYS OFF BUT NOT ALL. PLEASE PICK UP NEWSLETTERS EACH MONTH TO KEEP UPDATED ON IMPORTANT INFORMATION IN THE STUDIO.

**YOU'RE RESPONSIBLE TO FOLLOW THE TUITION DUE DATES AND TO CALL A MONTH IN ADVANCE IF HE/SHE IS NOT RETURNING TO CLASSES. DUE DATES ARE ON OR BEFORE THE 5<sup>TH</sup> DAY OF CLASS EACH MONTH. IF PAYMENT IS NOT SUBMITTED BY DUE DATE DANCER WILL BE DENIED CLASSES UNTIL PAID AND A \$25 LATE FEE WILL BE REQUIRED.**

THE STUDIO RULES & REGULATIONS:

- A NON-REFUNDABLE \$25.00 REGISTRATION FEE AT TIME OF REGISTRATION OF YOUR DANCER INTO THE STUDIO.
  
- TUITION MUST BE PAID BY THE 5<sup>TH</sup> OF EVERY MONTH. A \$25 LATE FEE WILL BE CHARGED IF TUITION IS LATE. IF YOU WISH TO MAIL TUITION THE STUDIO'S MAILING ADDRESS IS PO BOX 1191, PIONEER CA 95666. IF TUITION HAS NOT BEEN PAID FOR ONE MONTH WITH NO NOTIFICATION IT WILL BE ASSUMED THE DANCER DROPPED AND HIS/HER PLACE WILL BE FILLED.
  
- A NON-REFUNDABLE RECITAL FEE OF \$50 PER DANCER IS DUE IN SEPTEMBER TO PARTICPATE IN THE ANNUAL RECITAL IN JUNE.
  
- PARENTS ARE TO ONLY WATCH CLASSES FROM THE PARENT WAITING ROOM. PLEASE DO NOT WALK ON DANCE STUDIO FLOORS. THIS ALSO INCLUDES CREATIVE MOVEMENT CLASSES.
  
- PLEASE DO NOT BRING YOUR STUDENT LATE TO CLASS. IF YOUR STUDENT IS 10 MINUTES LATE OR MORE, THEY WILL BE ASKED TO WATCH THE REST OF THE CLASS. STUDENTS MUST BE INVITED ONTO THE FLOOR IF LATE OR IF THEY ASK TO LEAVE CLASS FOR ANY REASON AND RETURN TO THE FLOOR. THIS IS FOR THE SAFETY OF THE DANCERS IN MOVEMENT ON THE FLOOR.
  
- PLEASE HAVE YOUR DANCER COME TO CLASS FEELING PREPARED BY HAVING A HEALTHY SNACK AND WATER PRIOR TO CLASS, USES THE BATHROOM BEFORE CLASS, BRINGS A WATER BOTTLE TO CLASS WITH THEIR DANCE BAG, AND HAVE PROPPER DRESS CODE ATTIRE FOR THE CLASS INCLUDING HAIR STYLE. DANCERS MAY NOT WEAR LEOTARDS, TIGHTS, OR DANCE SHOES OUTSIDE AT ANYTIME; IT IS NOT APPROPRIATE. WHEN GOING IN OR OUT OF THE STUDIO COVER-UPS ARE GREATLY ENCOURAGED FOR THE PROTECTION OF YOUR CHILD'S BODY. PLEASE HAVE YOUR DANCER HAVE STREET SHOES FOR WALKING IN AND OUT OF THE STUDIO. IF YOUR DANCE WEARS THEIR DANCE SHOES OUTSIDE, THEY WILL NOT BE ABLE TO WEAR THEM AGAIN ON STUDIO FLOORS.
  
- THE GIRLS DRESSING ROOM MUST BE USED TO CHANGE. DO NOT USE THE BATHROOM FOR CHANGING. THE GIRLS DRESSING ROOM IS NOT A WAITING ROOM OR HANG OUT. PLEASE CHANGE AND COME INTO THE STUDIO TO STRETCH AND WARM UP OR GO UP AND WAIT IN THE PARENT WAITING ROOM.
  
- IF YOU WISH TO SPEAK TO AN INSTUCTOR FOR MORE THAN JUST A FEW MINUTES IN-BETWEEN CLASSES, PLEASE CALL CARA AGUSTIN OR THE SPECIFIC INSTRUCTOR TO SCHEDULE AN APPOINTMENT.

We have read and understand the Rules and Regulations of The Studio. We understand that tuition is due by the 5<sup>th</sup> of each month and if late a \$25 late charge will be added. We understand that in order to hold the dancer's place at The Studio; full tuition (unless notified otherwise) is due all 12 months of the year regardless of summer or holiday vacations. If tuition is not paid for one month without notification, we will assume your dancer has dropped from his/her classes and their spot will be filled. We understand a \$50 Recital Fee is due the month of September each year to reserve dancer's spot in the Annual Recital in June.

We have read and understand The Studio's dress code and will be dressed appropriately for each class including appropriate hairstyle. The dancers will wear cover-ups over their leotards and tights and wear street shoes when entering or existing the studio.

We have read and taken note of the 2017-2018 Season Calendar and understand dates are subject to change if necessary. We will check the front counter at the beginning of each month to pick up the monthly newsletter giving updates and important information about The Studio.

We understand that The Studio is a classroom and will not distract dancers during their classes and will use the parent waiting room if waiting during classes. We also understand being quiet during pick up and drop off is important while other classes are in session to ensure the quality of learning and teaching.
